Achieve Center, Inc.

Introduction

The Achieve Center offers diagnostic and treatment services for children and their families affected by neuropsychological/developmental disorders, chronic illness, and physical disabilities.

Services are provided by pediatric

neuropsychologists/rehabilitation psychologists, a developmental/behavioral pediatrician, pediatric clinical social workers, and marriage and family therapists to residents in central and northern Wisconsin.

The Community Need

The Achieve Center is the only pediatric mental health clinic in central and northern Wisconsin with a mission to serve children and their families with primary neuropsychological disorders such as traumatic brain injury, autism, cerebral palsy, ADHD, cognitive disorders, problems with executive functioning, as examples, and children in need of support who have chronic health problems and physical disabilities. More than 50% of the patients the Achieve Center serves are funded through the Medicaid program.

Future Goals

- 1) Day treatment program for children ages 4-8 years with problems with executive functioning.
- 2) Concussion clinic for children 0-9 years of age.
- Multi-disciplinary collaborative assessment and treatment program for children affected by parent substance abuse en utero and other secondary exposures.

History

The Achieve Center was founded in February 2007 as a result of an identified community need in central and northern Wisconsin. From its inception, the request for services has continued to increase resulting in an expansion of professional staff and facility.

AIDS Resource Center of Wisconsin

Introduction

The AIDS Resource Center of Wisconsin (ARCW) is a private, nonprofit health and social service agency that works to confront and alleviate the effects of HIV disease in Wisconsin. ARCW provides aggressive HIV education and prevention, access to comprehensive services for people affected by HIV disease, clinical research on HIV treatment, and HIV advocacy

The Community Need

HIV disease is compounded by a variety of socioeconomic factors that often serve as barriers to proper care and treatment. Poverty, homelessness, substance abuse, isolation, family issues and mental health issues further exacerbate a disease that must be treated and managed with complex medication regimens. ARCW serves over 2,600 patients per year with one-third having no health care payor source.

History

ARCW was formed in 1985 by three people to combat the newly rampant AIDS infection that was dominant in the gay community. In 1996, the dental clinic was opened and in 2001 the medical clinic opened. Today, ARCW is the fourth largest AIDS Service Organization in the country and has 125 employees located in nine offices including Wausau, Appleton, Eau Claire, Green Bay, Kenosha, La Crosse, Madison, Milwaukee and Superior.

Future Goals

Looking ahead, ARCW's highest priority is to keep the ARCW Medical Center at the forefront of HIV health care and advance the ARCW center of excellence to meet the challenges of the future. ARCW strives to continue to offer services regardless of the patient's ability to pay.

Introduction

The American Indian Resource Center (AIRC) is a newly formed organization established to support families and individuals seeking to maintain their values and ties with each other and their cultures. We provide a safe and welcoming place, including educational and culturally specific programming in order to promote the advancement of American Indian people. Our volunteer and career services will pair our clients with local business in an effort to make connections and develop understanding between Wisconsin tribes and the community.

The Community Need

American Indians living in urban areas are under-served in Marathon County and across the U.S. Nearly 60 percent of American Indians reside off the reservation and they face many hardships compared to non-Indians living in the same area. Urban Indians have a poverty rate of 20.3 percent as compared to 12.7 percent of the general urban population. This is only one of the statistics that demonstrates the need for AIRC. Our educational and cultural programs greatly benefit American Indians in our area now more than ever.

Future Goals

We want to develop a strong presence in the community while creating connections and developing understanding between Indians and non-Indians. We look forward to creating partnerships with local businesses while continuing to strengthen American Indian families and people in the area.

Giving Opportunities

The American Indian Resource Center of Marathon County is a community based organization seeking 501(c)(3) status and serves as a resource to American Indians and the community. Giving opportunities are available for current, ongoing and upcoming services and programming. Please contact the Board Director for a complete listing.

History

The American Indian Resource Center filed its Articles of Incorporation on December 10, 2010. Until we have our nonprofit status, we are working with the nonprofit group, Indigenous Circle of Nations, an American Indian Parent Advisory Group that formed in collaboration with the Wausau School District in 2008.

Services Provided:

Education, such as youth leadership, afterschool programs, and tutoring; cultural arts including drumming lessons, beading circles and community awareness; health services such as nutrition and exercise programs; Elder services including a foster grandparent program; career skills development and community engagement

Governance:

The American Indian Resource Center (AIRC) is governed by a four member board of directors. At least seventy five percent of the board members must be Native American.

Mission:

Our purpose is to support American Indian people of Marathon County seeking to strengthen their values and ties to their cultures.

American Red Cross – Marathon County Chapter

Introduction

For more than 125 years, the mission of the American Red Cross has been to help Americans prevent, prepare for and respond to emergencies. We have a long and proven track record of immediate response to major disasters, both natural and human-caused.

Through the American Red Cross, people mobilize to help their neighbors. Nearly 1 million volunteers and 35,000 employees of the Red Cross, from our community and across the nation, help provide these life-changing and often lifesaving services.

The Community Need

Last year in North Central Wisconsin *38,557* lives were touched through the work of the American Red Cross. Specifically,

- 282 military personnel and their families were assisted through Emergency Services to Armed Forces.
- 170 families were provided with shelter, food, clothing and other relief services.
- 92 disaster emergencies engaged volunteers and staff in relief efforts.
- 9,203 pints of lifesaving blood were collected through 194 blood drives.
- 12,320 people received community disaster and preparedness education
- 839 young people completed babysitter's training.
- 10,964 individuals took a CPR/AED and First Aid class
- *4,030* students took learn-to-swim classes, lifeguard training and similar water safety programs.

Future Goals

Disasters deprive families of homes and belongings, cause major disruptions to businesses and cost billions. This immense social and economic impact can be dramatically reduced if families, businesses and communities take proactive steps to reduce their vulnerabilities. Therefore, disaster preparedness and mitigation are top priorities of the American Red Cross.

History

Clara Barton founded the American National Red Cross on May 21, 1881. The Marathon County Chapter of the American Red Cross was chartered in 1917.

Giving Opportunities

Funding Sources:

The Red Cross is not a government agency; it relies on donations of time, money and blood to do its work. An average of 91 cents of every dollar the Red Cross spends is invested in humanitarian services and programs.

Services Provided:

Domestic disaster relief; communications services and comfort for military members and their family members; the collection, processing and distribution of blood and blood products; educational programs on preparedness, health, and safety; and international relief and development programs

Governance:

The American Red Cross is led by a Board of Governors with all of the powers of governing and directing, and of overseeing the management and affairs of the organization. The corporate governance principles of the American Red Cross are composed of a series of documents adopted by the Board of Governors and reviewed periodically to ensure they continue to meet the needs of the organization and reflect current industry best practices.

Mission:

The American Red Cross, a humanitarian organization led by volunteers and guided by its Congressional Charter and the Fundamental Principles of the International Red Cross Movement, will provide relief to victims of disaster and help people prevent, prepare for, and respond to emergencies.

Aspirus Comfort Care & Hospice Services

Introduction

Aspirus Comfort Care and Hospice Services offers hospice, palliative and grief care. When active treatment is no longer the focus of care for an illness, hospice care concentrates on relieving symptoms and supporting patients and their families. Hospice patients generally have a life expectancy measured in months rather than years.

Palliative care is available any time during a person's serious illness – much earlier than hospice. The goals of palliative care are to improve the quality of life for a seriously ill person and to offer caring support to them and their family both during and after treatment.

Grief care is an ongoing process that supports the family unit during a person's illness and continues on after a loved one's death. Support groups and educational programs extend out to all members of local communities, not just those served by hospice or palliative care.

The Community Need

A high-quality hospice program is dependent upon partnerships with individuals, businesses, churches, funeral homes, service groups and many others who surround people during their end of life.

Future Goals

Our goal is to continue to expand our services to meet the needs of our growing and aging population.

History

A nonprofit program founded in 1979, Aspirus Comfort Care and Hospice Services has a long history of providing excellent end-of-life care in north central Wisconsin. One of the first hospice programs in the United States, we partner with physicians, churches and local community groups to provide compassionate care for people in their homes, in the hospital and in other living facilities.

- Support the operations of the region's premier hospice and palliative care program
- Operate the Aspirus Comfort Care and Hospice Services' Grief Center; all services are provided free or at a nominal charge to members of area communities

- Community-Based match that meets independently. Partners are engaged in mutually agreeable activities and agency sponsored events.

The Community Need

In 2008, there were 15,622 households with children in Marathon County, of which, 28% (4,373) were single parent non-married couple households. The quality of life for children is likely to be higher when they live in a marriedcouple family. Therefore, youth living in single parent or nonmarried families are more susceptible to drug use, educational, emotional, and behavioral problems, and lower self esteem. However, these same youth can be receptive to positive reinforcement from positive role models, such as those provided through Big Brothers Big Sisters.

History

In our 35^{th} year, Big Brothers Big Sisters has become recognized as a consistent leader among the 20 affiliates of Big Brothers Big Sisters of America. In 2001, we lead the state in service growth (over 369% increase) and revenue growth (over 40% increase) and developed a regional approach to services in our three county service area with offices in Spencer, Merrill, Antigo, Mosinee, and Wausau.

What began as a collaborative project among three local agencies in the 1970's, has grown to become an active partner agency with several county governments, multiple partner agencies, and five school districts.

Future Goals

Big Brothers Big Sisters focus is "longer and stronger matches." The goal is to have matches continue after the 12month period. These longer relationships are statistically better for the child involved in the match. This will be achieved by focusing on Community Based mentoring and trying to grow in that area over the next few years.



In addition, many elderly residents struggle to meet their financial needs as their savings and income are insufficient to cover their living expenses and health care costs. Faith in Action strives to help those who are struggling by providing services at no charge to the client.

History

Faith in Action of Marathon County, Inc. was founded in 2002 by a group of concerned citizens in the Wausau Area who recognized a need to care for their homebound neighbors who may be isolated and living with chronic health conditions or disabilities. It is one of over 600 independent Faith in Action programs in the United States that began with grants awarded by the Robert Wood Johnson Foundation.

The Community Need

As baby boomers age and people live longer, the elderly population of Marathon County will continue to increase. As a result, the demand for supportive services to enable elderly and disabled residents to remain independent is also increasing. Unfortunately, many elderly residents do not have the resources necessary to meet their financial and health care needs. Due to this barrier many people who could remain in their own homes with just a little assistance are forced to choose institutionalized living. This creates a drain on local communities as 63% of the cost of nursing home care is met by tax dollars. In order to provide support to our elderly and disabled neighbors and lighten the burden on communities and families, FIA provides assistance to maintain independent living at no cost to the client.

For low income clients without health insurance, United Way support of FCS allows for fees to be charged based on household income and size. During 2001 the eight clinical staff provided services to 1398 individuals and families from Marathon County and surrounding area. Specialty services include

- Marital/relationship counseling
- Depression and anxiety disorder treatment
- Parenting mediation during divorce/separation
- Co-Parenting Treatment for conflictual Parents following divorce
- Addiction treatment (adults and youth)-individual and groups
- CHOICES: Intensive Substance Treatment Program for Adolescents
- Veteran mental health services
- Trauma treatment including EMDR
- Employee Assistance Program services

The Community Need

FCS provides services on a fee-for-service basis. Generally most health insurance plans can be billed for specific medically diagnosable conditions. "Sliding fees" can be arranged for families without health insurance and is based upon household income and family size. This is possible through United Way support of FCS. Even when the local employment economy is strong, 30% of our clients do not have insurance coverage and utilize the available sliding fees.

FCS operates efficiently to provide quality therapeutic services at a reasonable cost. Special grants/gifts are always welcomed and needed to develop additional services needed within the area. Such new services are only limited by funding to create and initiate services. Gifts provided would assure the continued availability of non-tax supported services within the Wausau extended area.

The Community Need

Central Wisconsin needs comprehensive, confidential, high-quality, low-cost reproductive health care services. An intended child is likely to be healthy, raised in a healthy home, and has a better chance to succeed.

Communities benefit when families can plan for the future. Good nutrition and healthy foods are the foundation for a healthy pregnancy, a healthy baby, a healthy family, and a healthy community. Through the Women, Infants, and Children (WIC) Program, FPHS helps mothers and children get healthy and stay healthy.

Voluntary family planning allows people to choose their family size according their own needs and beliefs. FPHS does not provide abortion services or counseling. FPHS supports access to quality health care that improves the lives of families and generations to come.

History

For over 35 years, Family Planning Health Services has served central Wisconsin women and their families. FPHS provides maternal and child health care services to over 12,000 women and their families in seven counties throughout Central Wisconsin: Adams, Juneau, Langlade, Lincoln, Portage, Marathon, and Taylor.

Programs within FPHS include: the *Women, Infants, and Children* (*WIC*) *Program* in Lincoln, Langlade, and Marathon counties; the *Reproductive Health Program* within the seven counties which incorporates community presentations addressing reproductive health education and information. Family Planning Health Services may also provide additional programs suited to meet the needs of our clients.

Giving Opportunities

Endowment Fund: Family Planning Health Services' Endowment Fund was established to help ensure that quality reproductive health services will always be available. HMC goals are to identify, maximize, and evaluate community health improvement strategies. This work is achieved through a detailed action plan which details the following objectives:

History

HSMC obtained its nonprofit status in 1967. In 2008 the organization moved from a small animal shelter at a Kent Street location to 7001 Packer Drive in Wausau. Throughout the decades the goal has remained the same: to end animal abuse.

The Museum serves north central Wisconsin communities – residents, school children, and visitors – as the only full-service art museum offering a permanent collection, changing exhibitions, sculpture garden, education programs, and ongoing opportunities for lifelong learning and enjoyment of the visual arts.

The Community Need

A highly treasured and much-used community resource, the Museum is well-known locally and further afield, which is reflected in the *Wisconsin Trails* designation of the Woodson as the state's "Littlest Museum with the Biggest Reputation."

As the Museum has grown dramatically during its 35-year history, the demand for services also has increased tremendously. While income from the Museum's endowment provides approximately 50% of the annual operating budget, active annual and long-term fundraising are essential. Introduction

Marathon County Child Development Agency (MCCDA), Inc.'s Head Start is a state and federally funded program committed to helping low-income preschool aged children, their families, and communities overcome the effects of poverty and prepare the children to start school in operation in Marathon County since 1966. Each child is provided with an appropriate learning environment lead by licensed preschool teachers which will stimulate each child's social, intellectual, physical, and emotional growth and development. The program strives to strengthen families and the communities they reside within by providing or linking families to local resources for health, dental and nutritional services, social services, mental health services, services for children with disabilities, and provides opportunities for parent governance and involvement. The program meets both federal standards and state day care licensing regulations and thus has a high level of accountability and integrity. The program has a full federal review every three years and a state licensing renewal review every other year.

The Community Need

Head Start operates in Marathon County to serve the county's most disadvantaged of our youngest citizens – preschool age children. These are children whose opportunities are constrained by economic disadvantages faced by their families. When Head Start succeeds, these children go to school ready to learn and have a high likelihood of success both in life and school.

Research has shown that Head Start is an economically effective program that creates incredible change in the lives of our country's neediest children and families. One dollar invested in the Head Start program has been shown to return five to seven dollars in later reduced special education costs, school drop outs, teen pregnancies, economic dependency and incarceration costs.

Head Start has long known that to succeed in school and later in life, children must be healthy, nourished, socially competent, and have a healthy self-esteem, as well as strong, supportive, caring families. The program tackles a wide range of issues that poverty generates, including substance abuse, violence, homelessness, single-parent households, inadequate childcare, unemployment, and numerous other problems and stressors that challenge a family's resources.

While originally called into existence to meet the placement and treatment needs of adolescent males and females, the mission of MYS has been expanded to meet the expressed needs of the Wausau Community for services to young adults with developmental disabilities and mental health issues.

The Community Need

There continues to be a demonstrated need for specialized placement/treatment services for seriously troubled adolescents and their families. Reynolds Group Home is the only Wausau based program available to address that need in a community based residential setting. Additionally, the community has continued to express a need for services and living accommodations for young developmentally disabled adults; male and female. For the past 10 years Marathon Youth Services has helped meet that need as well, and continues to adjust to the changing needs of its collateral agencies.

History

Since 1978 Marathon Youth Services has existed to meet the needs of adolescents and their families and in recent years the needs of young developmentally disabled adults as well. Beginning as a family operated facility providing group home services to boys and girls, we have grown to an organization lead by a Board of Directors and Executive Director, employing 32 experienced and well trained care providers, to include a Licensed Professional Therapist. In addition to our adolescent group home facility, we also operate 3 separate residential facilities for young adults, and provide independent living supervision/services in several separate apartment settings as well.

Future Goals

Marathon Youth Services will continue to meet the needs of our current client population, and will strive to meet the changing needs of our collateral agencies. It remains our intention to adjust to the financial realities of the current economy while maintaining the service integrity and value that we have become known for.

In 1999, a group from Stevens Point merged into the Wausau based NCCT. Currently, NCCT protects properties in Adams, Lincoln, Marathon, Portage, Taylor, and Waushara Counties.

Future Goals

NCCT is committed to identifying and preserving properties with significant natural value and land uses such as forestry and agriculture.

Fortunately, while the need for technical education is increasing, it remains a good value. The financial challenges faced by students increase each year as available resources become more limited. The NTC Foundation responds to these unmet financial needs with scholarships and short-term emergency loans and grants for students who otherwise may not complete their education. The Foundation annually awards more than 400 scholarships valued at \$284,000. Scholarships range from \$200 to \$2,000 and are made possible through the generous spirit of area individuals, organizations, businesses and foundations.

History

Introduction

Raptor Education Group, Inc. (REGI) is a 501(c)(3) nonprofit organization, celebrating its 20 year anniversary in 2011. In that time it has grown to an internationally recognized wildlife facility. Seven hundred to one thousand patients are cared for annually at the rural Antigo based facility. Over two hundred programs Wildlife/ Environmental education programs were given in Marathon County and adjacent areas in 2011. College interns and veterinary students come from universities throughout the U.S. to train at REGI during the summer season.

The Community Need

REGI is currently the only federally permitted wildlife facility in north central Wisconsin. Federal permits are required to care for all native bird species due to the migratory bird treaty act. We care for all injured wild birds from hummingbirds to bald eagles. Our patients include those that have become sick or injured in some manner including being hit by cars, hit windows, accidental poisoning, and orphans. REGI also does wildlife education programs for schools and adult groups in central Wisconsin. In 2010, we cared for aver 700 birds many from the Marathon County area. The education aspect of our work is popular with the Marathon County school districts and those of the surrounding area. Our programs are used to augment the teaching schedule for "outdoor school" as well as other class work. Students from UW Marathon, NTC, Globe University and other universities around the country receive training at our facility.

History

REGI was developed in 1990 in Antigo, WI by founders Don and Marge Gibson. It was incorporated in 1991. Since that time the organization has grown from a volunteer organization to currently having 5 full time staff and 2 parttime as well as a host of volunteers. REGI is one to the largest facilities for avian wildlife care in the country. REGI has received numerous awards from the DNR and other groups for our work with endangered species as well as nonlisted wild avian species.

Future Goals

Responding to the need for wildlife care and education REGI will continue to grow and develop.. IN addition to caring for injured and orphaned wildlife the REGI organization has a very active international training program for wildlife professionals as well as summer programs for children.

Introduction

Founded in 1993 by Nan and Gary Zastrow after the death of their son, the organization provides information, education, and support before, during, and after the event of death. Wings works with local sponsors, including funeral homes and Aspirus Comfort Care and Hospice Service, to host two seminars each year. A spring seminar brings a noted speaker in the field of grief to Wausau. Two sessions, one for the bereaved and a professional seminar are held, each offering CEUS. A "When the Holidays Hurts" program is hosted by Wings the first Tuesday of December. Additionally, Nan and Gary facilitate three education and support groups each year and give public presentations. They have an active website and send a free quarterly ELetter to those who subscribe.

The Community Need

Grief touches everyone's life at sometime. We are seldom prepared for the emotional conflicts and changes it brings into our lives. Wings is prepared to assist individuals through the process by giving them hope to honor the past and rebuild the future.

History

Founded and active since 1993. Wings published a quarterly magazine from 1993-2003. In 2003, Nan became a regular columnist for "Grief Digest," a national magazine. An ELetter replaces the magazine once distributed through print. Nan is a published author of several books. The organization is composed of volunteers. No staff receives monetary compensation for their work. We reach people via email, web, ELetter, nationally and internationally.

The Community Need

Unfortunately there is no community that is not affected by domestic and sexual violence. Statistically speaking, 1 in 4 girls and 1 in 6 boys will be sexually assaulted before they reach the age of 18. One in four women report that a husband or boyfriend at some point in their lives has physically abused them. Violence is the reason stated for divorce in 22% of middle class marriages. This violence crosses all socioeconomic classes, and infiltrates into families at all educational levels. There is no race or class of people that are not affected. In addition to services to victims, it is also a vital role of the agency to provide community education about the prevalence of the violence so that we can eventually end the current suffering and prevent future violence.

Vision


Our vision as a model organization, empowers communities and individuals who have survived the effects of violence and oppression through the provision of quality programming, advocacy and education. The ultimate goal being to reduce/eradicate violence.

We serve anyone affected by domestic and sexual violence regardless of gender, sexual orientation, age, ethnicity, or ability.

Incorporated in 1978, as a drop in center staffed solely by volunteers, The Women's Community, Inc. has grown to provide comprehensive services to victims of domestic or sexual violence including: emergency safe shelter, 24 crisis hotline with toll free access, legal advocacy (for example assisting in filing a restraining order), supportive one to one counseling, support groups, criminal justice support (for example attending court hearings with or for a victim), meeting victims in emergency room, personal advocacy, information and referral, and community education. We offer special programming for children that witness domestic violence, and for children that have been sexually abused, for non-offending parents of children, for elderly victims, for Southeast Asian victims, Latina victims, and for victims in the rural parts of Marathon County. All of the services provided by the agency are free of charge.
