APPLICATION DEADLINE: February 15

YOUR APPLICATION MUST INCLUDE:

- Transcript of most recent grades
- List of extracurricular activities (downloadable form available online)

CRITERIA FOR SELECTION

- Graduating senior from Wausau East High School
- Dedicated to the environment
- Displaying a strong work ethic, a desire to do things right, and to make things better
- Demonstrating the characteristics of integrity, compassion, caring, empathy, and kindness
- Planning to pursue an education in any field of study at any accredited 4-year college or university
- GPA is not a factor in selection

ANNOUNCEMENT

The recipient will be announced at the Wausau East High School senior awards ceremony in the spring.

PAYMENT OF THE SCHOLARSHIP

The recipient will receive a congratulatory letter from the Community Foundation after the awards ceremony, instructing them on how to receive their scholarship funding. The student must provide proof of registration to the Community Foundation office for payment to be initiated. The Foundation will make payment directly to the college or university the student is attending.
